Citizens can apply using the Union Park *Micro-Grant Application* at the UPDC Website. Micro-Grant information is also available on the UPDC Google Drive.

The Micro-Grants are for up to \$400.

Priority for Funding

Grant requests submitted by March 15 will have priority for funding. After the priority projects are funded, other projects may receive money from remaining funds.

Proposals submitted after March 15 will be approved on a "rolling basis."

NSVC members reviewed the 2024 Work Plan. The 2024 Work Plan stated what the Neighborhood Sustainability & Vitality Committee (NSVC) planned to do in 2024.

NSVC members did a survey by asking members of the Merriam Park Design Advisory Committee. We determined the level of interest in a new Improvement Association.
Addressing climate change and climate resilience efforts locally	 Send one letter about climate change to an appropriate official. We should also have one expert give a relevant talk at an NSVC meeting. Jerry Clendenin links climate change to the loss of Ash trees. We are seeing heat record after heat record. Loss of trees make Union Park neighborhoods hotter and hotter. He suggests a program to education residents on how to work the City of Saint Paul on replacing the lost trees as fast as possible. 	NSVC did not accomplish anything about climate change in 2024.

NSVC did not make the Midway Peace Park an annual event because it still does not have solid funding. NSVC members participated in many other events.	
Maintain relationship with Union Park	Ellen Fee and Kirsten Fryer are members of the UPDC Board of Directors.	Goal achieved!	
Community gardens	The two community gardens are doing well. They can ask for help when they need help.	UPDC is the financial steward for the gardens.

We discussed how to create the "Union Park Brand." The brand needs to show that Merriam Park and 6 other neighborhoods are parts of Union Park. We discussed ideas for a new Union Park map or diagram. Alice Messer, Design & Construction Manager for Saint Paul Parks & Recreation, visited the NSVC meeting for October, 2023. She said there is a priority list of parks that are due to get new playground equipment.	The NSVC got the Merriam Park Design Advisory Committee off to a start.
	Merriam Park has a lower priority than some other parks. We discussed how to lobby to move Merriam Park to a higher up position on the list.	
	Another issue is the need to repair the Merriam Park Rec Center building.	
Engage with and advocate for Merriam Park renters	We discussed the idea of providing welcome packages for renters that are moving in to Union Park.	We did not make any progress on this activity.
	Joseph Hughes is a UPDC Board member and a landlord. We will ask him for ideas on how to engage with renters.
